No.F.4(5)/2015-NCC: In exercise of the powers conferred under the Federal Supervision of Curricula, Textbooks and Maintenance of Standards of Education Act 1976, Section 3 (2) (a) the competent authority i.e. Secretary, Ministry of Federal Education & Professional Training (M/o FE&PT) has been pleased to approve the National Curriculum of Pakistan (NCP) for grades IX to XII for Urdu, English, Pakistan Studies, Math, Physics, Chemistry, Biology, Computer Science & Entrepreneurship, and Islamiat (compulsory) (X1 &XII) available at ncc.gov.pk to be implemented in all the public and private educational institutions of Islamabad Capital Territory (ICT) and the educational institutions under Federal Government in the country. The curriculum for grades IX and XI will be implemented from the Academic Year 2024 while for grades X and XII from the academic year 2025. This curricula shall be applicable to all categories of students unless notified separately for any particular category of students. An implementation framework is appended with this notification.
